3. All subcontracted personnel, whether Permanent or Casual staff, are registered with the Department of Labour (C.O.I.D) Act, and in the event of there being an accident, they are eligible for Workman's Compensation.
4. The use of Cradles and Props is undertaken at the Yacht Owner / Representative / Contractors own risk. ABYC does not warrant their integrity, and boat owners are encouraged to use their own Cradles / Props.

### **Contractors**

Contractors engaged by the Owner or Owner's Representative will be subject to the above Indemnity.

### **Payment**

All accounts will be settled prior to service.

### **Long Term**

Long term rates are subject to written application to EXCO

### **Late Penalty Clause**

For any excess days on the Hard, double rates will apply, unless prior agreement has been reached and confirmed in writing with the Executive Committee of Algoa Bay Yacht Club.
