**LIABILITY, WAIVER, CLAIMS,  
 EXPRESS ASSUMPTION OF RISK & INDEMNITY FORM  
 ASSOCIATED WITH THE ALGOA BAY SAILING WEEK 2017 REGATTA AND RELATED ACTIVITIES**

I, the undersigned \_\_\_\_\_ in my personal capacity and on behalf of the owner/s of the Yacht \_\_\_\_\_ (hereinafter) referred to as "the Yacht") freely accept and expressly assume all risk, danger and hazards that may arise from my participation and the participation of the yacht in the Algoa Bay Week Sailing 2017 Regatta (the "Regatta") which could result in personal injury, loss of life and damage or loss to property and to the yacht itself.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS & INDEMNITY**

In consideration of my and the yacht's participation in this Regatta, as well as the use of the facilities, moorings, crane and other equipment, provided and/or organized by the Algoa Bay Yacht Club (ABYC) , I hereby undertake as follows:

1. To waive, release and indemnify the ABYC, the Algoa Bay Sailing Marina (ABSM) and/or South African Sailing (SAS) against any and all claims, however arising, and specifically but not limited to the involvement of the yacht in the Regatta, use of all facilities, moorings, crane and other equipment provided by the ABYC, ABSM and SAS, for any loss or damage resulting from bodily injury, loss of life or loss or damage to the yacht or property.
2. To release the officials, directors, employees, representatives, agents and volunteers of either the ABYC, ABSM and SAS, from any liability and responsibility, whatsoever, for any claims or causes of action that I, my estate, heirs, executors or assigns or owner/s of the yacht may have for personal injury, damage or loss to property or wrongful death arising from my participation and the participation of the yacht in this Regatta, arising from any cause whatsoever.
3. By executing this document, I, in my personal capacity and on behalf of the owner/s of the yacht, agree to hold the ABYC, ABSM and SAS and/or any persons set out in paragraph 2 above, harmless for any injury or loss of life or damage to property, which may occur directly or indirectly in connection with my participation and the participation of the yacht in this Regatta and indemnify them against any and all claims which may arise in this regard.
4. By signing this undertaking, I am not relying on any verbal or written representation or statement made by the ABYC, ABSM and SAS and/or any persons set out in paragraph 3 above, other than what is set forth herein.
5. I declare that the I/the skipper of the yacht is competent in handling the above mentioned yacht in all conditions, and that he/she/I have the relevant certificate to take the said vessel to sea.
6. I confirm that I/the skipper am fully aware of SAS Rules and regulations governing the wearing and/or carrying of safety equipment on the yacht, and that the yacht entered, complies with the minimum buoyancy requirements. I further confirm that the said yacht has a current COF.
7. I agree that competitors sail entirely at their own risk and agree that none of the organizations, sponsors, ABYC, ABSM, SAS and/or the persons concerned in the running of the Regatta accept liability for damages, injury or loss of life. I acknowledge R.R.4
8. If any provision of this undertaking is found to be unenforceable or invalid, that such provision shall be severed from this contract. The remainder of this undertaking will therefore be construed as though the unenforceable provision had never been contained in this document.
9. I hereby declare that I am competent and duly authorized to sign this undertaking.
